

  - b. Candidates provisionally shortlisted under the reserved category against reserved vacancies must produce a valid caste certificate, along with all other required documents, at the time of document verification/interview; failure to do so will render them ineligible to appear for the interview.
  - c. Candidates belonging to reserved categories but provisionally shortlisted against unreserved (UR) vacancies are also required to produce a caste certificate to claim benefits of reserve category.
  - d. In case of any discrepancy, falsification, or non-fulfilment of eligibility criteria at any stage, the candidature shall be summarily rejected, and the decision of the recruitment authority shall be final and binding.
